

TERMS AND CONDITIONS FOR THE 2025 SNOWBALL

Live Auction

There are ten [10] live auction items available for bidding at Snowball 2025 and the terms and conditions below relate to these items.

1. The auction will be conducted at Snowball and the Auctioneer Andree O'Brien will be announcing bids and the successful bidder of all auction items.
2. Items will be sold to the highest eligible bidder announced at the close of bidding.
3. Bids will not be accepted after the close of the auction.
4. Bids are in Australian dollars. Minimum bid increments will be announced by the auctioneer.
5. No auction item may be redeemed for cash.
6. Entry is open to residents of Australia who are eighteen [18] years of age or older at the time of bidding.
7.
